Whereas the open or enclosed land (not occupied by a building) admeasuring about 1.40:20 sq m. forming part of your premises bearing CTS No:366..... of VillageGendawali..... situated at R.H.S. ch. 4:347. n. 4:365..... lies within the regular line of the public street as prescribed by the Commissioner under Section-297 of the Bombay Municipal Corporation Act -1888. You will be eligible for TDR / FSI benefits if not granted previously.

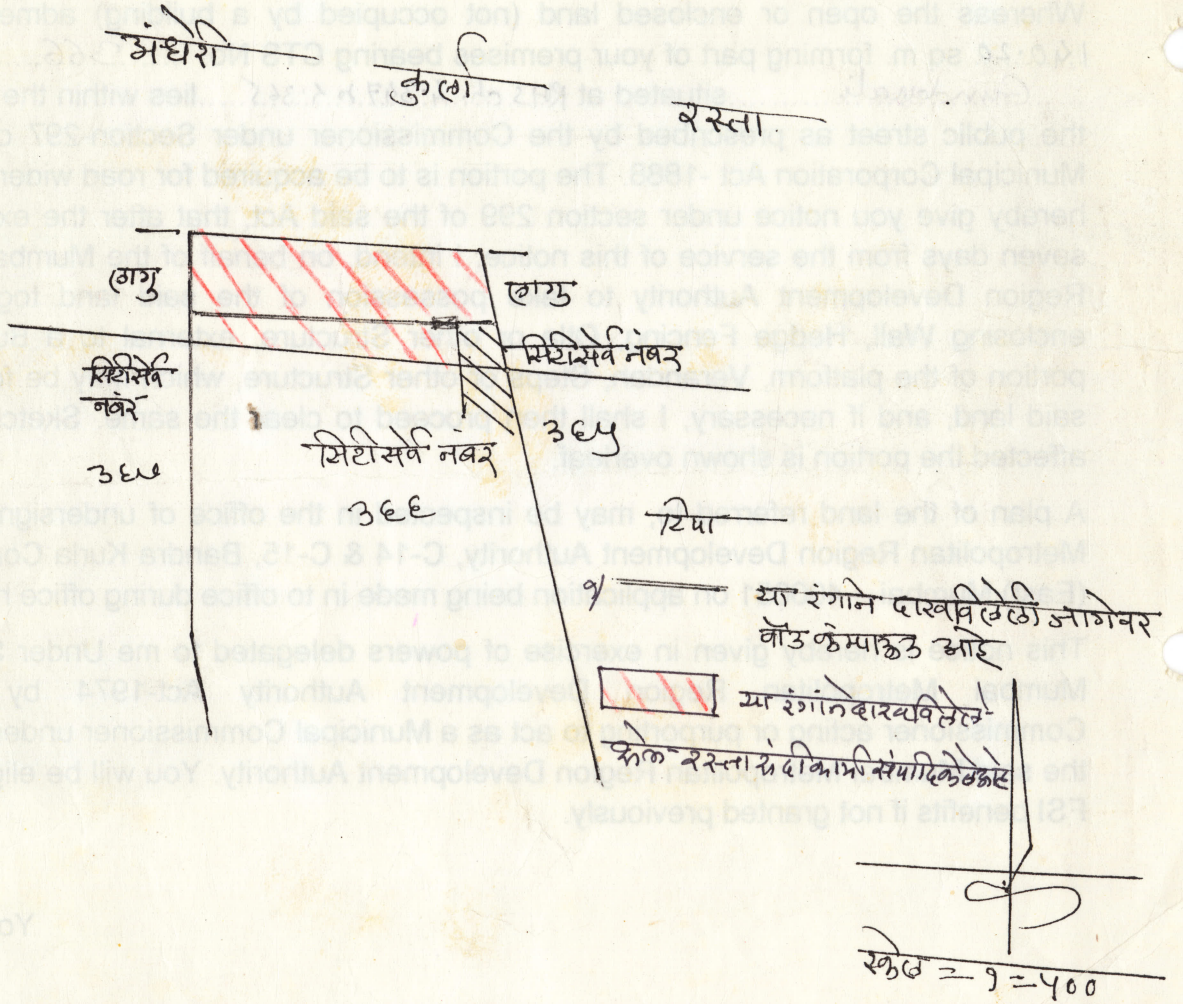
